Commissioners to discuss county taxes

Tuesday's Commissioners Court will begin with a public hearing regarding the proposed 2021 budget for Washington County.

The proposed budget will raise \$540,009, or 2.886%, more revenue from property taxes than the previous year. The increase comes from new property added to the tax roll which, in total, is set to bring in \$594,000.

Commissioners will also discuss levying or adopting a tax rate of \$0.4950 per \$100 to provide more money for maintenance and operations.

Immediately following the public hearing, commissioners will take a record vote on the 2021 budget.

The court will also hear monthly reports from the sheriff's office, emergency medical services, Washington County E911, IT department and the veterans service officer.

Traditionally, Camp For All has hosted camps for kids who come from all over the nation to enjoy a safe haven of fun and meet other kids who share the same set of different abilities. Now Camp For All is opening its gates to host family camps: Camp For Y'All.

local paper, and now you just Google it. When I applied, they actually called me and said, 'You meant to apply to Texas right?' since there's a Washington County up in Oregon and they wanted to make sure I knew what I had applied to," said Williams.

To keep relocation costs low, and because many things were closed due to the pandemic, Williams packed his car and stayed in a tent each night during his journey from Oregon to Texas.

"It took me a week," he said. "I packed a tent and everything I own in my mini cooper and drove and stayed at national parks that had been opening up. I took my time getting here and ate at grocery stores. Nothing else was really open so why not?"

Instead of worrying about things he cannot control, Williams viewed the move the same way he views his work: a way to have fun.

"It was kind of a once in a lifetime opportunity to drive across the U.S. for work. You have to have fun while you do it. Every day should be fun or there is no point in doing anything," said Williams.

However, starting a new job during a pandemic did not come without challenges.

"It's different because the events industry got hit really hard with the pandemic," said Williams. "The wedding industry got hit hard. Quinceañeras, celebratory kind of events had a hard time because events like that function off of having a lot of people and when you can't have that large volume of people or a space that can accommodate

that kind of large volume of people, especially in a time of uncertainty, it makes it a little difficult. However, what is nice about Washington County, and what our saving grace has been, is livestock. Livestock is very easy to social distance and abide by mask requirements and sanitation requirements. That has been one of our saving graces to get through the pandemic."

Joel Knox did not have a major move like some during the pandemic, but he did make the journey into working a second full-time job.

After moving to Brenham in 2016 and becoming a paster with his wife, Danielle, at the Vineyard Church of Brenham in 2018, Knox decided there was no better time than the present to find a second source of income. He had worked in IT previously for a school district and was originally hoping to find something within the field.

"I hoped to maybe find something

with Brenham ISD or something more part-time but there wasn't really anything available," said Knox about the job search.

According to Knox, the interview process was very similar to any other job, just with more precautions and masks. He has served as the IT specialist for Washington County since the beginning

of August.

"There have definitely been some things that took getting used to," said Knox about beginning a new job during the pandemic. "Face masks are required in the courthouse and in all of Washington County facilities. And we are required to get our temperature taken

each morning." It wasn't just wearing face masks that took getting used to though; learning who people are under them also created problems.

'There were quite a few people when I first started that I didn't know what they looked like. It was kind of awkward making initial interactions," he said.

Though he has adjusted into his new role, Knox is ready to experience work without the pandemic.

"I'm really thankful for the opportunity and I am looking forward to work after the restrictions that are being imposed because of the pandemic are gone," said Knox.
