Camp For All partners with other nonprofit organizations to transform the lives of children and adults with challenging illnesses, disabilities, or special needs and their families, providing opportunities to discover hope, grow self-confidence, and realize they are not alone. More than 200,000 campers have attended since 1998. Camp For All in Burton, Texas, has the ability to serve nearly 9,000 campers, annually. Construction is almost complete on the second Camp in Chappell Hill, Texas, which will open in the summer of 2027. This will double the number of campers served to meet the ever-growing need. Barrier-free, both Camps welcome campers with cancer, autism, Muscular Dystrophy, lost limbs, spinal cord injuries, sickle cell, renal issues, epilepsy, visual and hearing challenges, and more.
